

CONFERENCE SPEAKERS

Ned Cooney is a former member and Board Chair of the Board of Directors of the Montana Nonprofit Association and has served as a member of MNA's Nonprofit Public Policy Council since its start in 2006.



He serves as adjunct faculty at Flathead Valley Community College in nonprofit topics, and formerly taught in the Nonprofit Management Certificate program at University of California, Riverside.

Ned was raised in Southern California and holds a Masters Degree in Social Work from California State University. Before falling in love with the Flathead and moving with his wife Cathy to Bigfork in 2004, he ran two nonprofits, the Volunteer Center of Riverside County operating a variety of volunteer and social service programs, and the Resource Center for Nonprofit Management, specializing in training and consulting with nonprofit organizations. Ned was a board member for the Riverside Community Health Foundation, a hospital/health care conversion where he served as chair of the Trust Uses Committee. In that role, Ned led a grant making process focused on improving health outcomes and access.

In his leisure time, Ned enjoys playing guitar, hiking, bicycling, boating, card and trivia games, and spending time with wife Cathy, friends and family.

Bryan Tavary is a Montana native and graduate of Helena High School and the University of Montana. He spent a decade working EMS in Las Vegas and New Orleans, while also serving as a firefighter for the city of Baton Rouge, Louisiana. Bryan currently serves as the Community Integrated Health-



Community Paramedicine Education Specialist in EMS & Trauma Systems within Montana Department of Public Health and Humans Services (DPHHS). Before joining EMS & Trauma Systems, Bryan was the Healthcare Preparedness Program Coordinator developing healthcare coalitions around our great state.

Bob Drake graduated with a BS in Accounting from Montana State University in Bozeman in 1984. After graduation, he went to work for KPMG Peat Marwick as a CPA in Midland, Texas. He spent ten years with KPMG in their headquarters and their

Midland, TX and Columbus, OH offices. Bob moved back to Helena in 1995 and became the CFO for Bison Engineering, Inc. where he helped manage the 30 person firm for the next 10 years. Bob started as a firefighter with Lakeside Volunteer Fire Department in 1995 and then became a Trustee in 1996. He served as a Trustee on the Board of Lakeside Fires Service Area until he was appointed Fire Chief of Lakeside in 2001. In 2005, Bob became the Fire Chief of Tri-Lakes Fire Service Area when it was formed by combining Lakeside Fire Service Area with Canyon Ferry Fire Service Area. In 2006, Tri-Lakes hired Bob as its fulltime Administrator where he currently serves. Bob's private business and public service experiences provide him with a valuable perspective on how to help Montana Fire Districts and Fire Service Areas function effectively

Bill Farhat has been Fire Chief of the Big Sky Fire Department since 2011 and has been a member of both the fire and emergency medical services for 30 years,



serving as a volunteer or career employee in both rural and urban environments. Chief Farhat holds numerous fire service certifications and designations and has been a paramedic for 27 years. In addition, he was also a career law enforcement officer where his duties included fire/arson investigations, being a hazardous materials technician and being a member of a regional weapons of mass destruction response team. Chief Farhat and he holds a Master of Science in Threat and Response Management from the University of Chicago and a Bachelor of Applied Science in Public Safety from Siena Heights University.

Ron Lindroth moved to Montana

in 1012 with his family from

Colorado. He serves as the Fire Chief of Central Valley Fire District in Gallatin County, Montana. Chief Lindroth's fire service career started as a wildland firefighter with the U.S. Forest Service in 1976. In 1980, he became a structure firefighter and has advanced through the fire service ranks in Breckenridge, Ft. Collins, and Steamboat Springs, Colorado and Belgrade, Montana. He holds an Associate's degree in Fire Science, a Bachelor's degree in Biology, a Master's degree in Fire Service Leadership, a U.S. Fire Administration designation of Executive Fire Officer, and the Center for Public Excellence's Chief Fire Officer Accreditation. Ron is married to his wife Racquel of fifteen years, and has two daughters. They are active members in the Springhill Presbyterian Church and Manhattan Christian School. His personal interests include camping, hunting, fishing, and raising Golden Retrievers.

Shane Grube was born and raised in West Yellowstone, MT. His first experience with structural firefighting was using large rotary snow blowers and loaders to put snow on structure fires in an attempt to suppress the fire. This has been the norm in West Yellowstone during times when fire trucks were frozen up or not available. Chief Grube started in the fire service as volunteer in 1997 with the creation of the North Side Rural Fire District. In 2000 he was made Assistant Chief a position he held until 2005 when he was made Chief of the Department. In 2007 after 2 structure fires on the same day in the rural unprotected area west of West Yellowstone and south of Hebgen Lake. A campaign kicked off to bring the south side of Hebgen Lake into the Fire District. Once that was completed the North Side Fire District changed its name to Hebgen Basin Fire District. Now all private land within the Hebgen Basin was under the protection of the Hebgen Basin Fire District the exception of the Town of West Yellowstone. In early 2008 the Town of West Yellowstone and the Hebgen Basin Fire District entered into negotiations for the District to Annex the Town of West Yellowstone into the Fire District, which went into effect March 2009 at which point Chief Grube stepped down as Chief into an Assistant Chief position and went out and hired the Districts first fulltime paid Chief. The person who stepped into the role was Chief Scott Waldron. In 2011 the District elected to hire its first fulltime paid Assistant Chief which Chief Grube was hired for. He worked in that position until Chief Waldron's retirement in the spring of 2015 at which time Chief Grube took over the Department again.
